North Carolina Heat Report August 6-August 12, 2023




This Week

- Daily maximum heat indices ranged from 89°F to 100°F (median = 96°F) at Raleigh-Durham International Airport (RDU)
- 192 emergency department visits for heat-related illness were identified (Figure 1)
 - 70% of visits were among males (Table 1)
 - The highest proportion of visits were among patients aged 25-44 years (36%) and patients aged 45-64 years (29%) (Table 1)
 - The most frequent heat related diagnosis code was Heat Exhaustion (n = 52) (Table 2)
 - The highest proportion of visits occurred in hospitals in the Piedmont (62%) and Coastal (33%) regions
 - 13% of visits occurred in hospitals in the Sandhills sub-region¹
- During August 6-August 12, the proportion of emergency department visits for heat-related illness was 0.20%, lower than the 2018-2022 average of 0.28%. (Figure 2)

Season to Date (August 12, 2023)

• 2,598 emergency department visits for heat-related illness have been identified (Figure 1)



¹The Sandhills sub-region is comprised of the following counties from the Piedmont and Coastal regions: Bladen, Cumberland, Harnett, Hoke, Lee, Montgomery, Moore, Richmond, Robeson, and Scotland.



NOTE: Emergency department visit records and maximum heat indices were obtained from NC DETECT and the State Climate Office at NC State University, respectively. Heat-related illness is captured through a near real-time keyword search for 'heat', 'hot', 'hyperthermia', 'heat cramp', 'heat exhaustion', 'heat stroke', and 'sun stroke' in chief complaint or triage notes of emergency department records or a diagnosis code for heat-related illness. Hospitals transitioned from the ICD-9-CM diagnosis code standard to ICD-10-CM in 2015. This transition may impact the number of emergency department visits with a heat related illness diagnosis.
