SUBJECT: Potassium Iodide (KI) Distribution to Schools

In 2002, North Carolina ordered 750,000 tablets of potassium iodide (KI) from the federal government and began distributing them to residents and workers within the 10-mile Emergency Planning Zones (EPZs) of the four nuclear power plants (NPPs) in or adjacent to North Carolina. If KI is taken prior to or soon after exposure to a release of radioactive iodine (RAI), such as might occur during an incident at an NPP, it blocks the uptake of harmful RAI by the thyroid gland, and can prevent thyroid cancers and other thyroid diseases caused by RAI. Although evacuation remains the preferred emergency response to a serious NPP event, KI is an effective supplement to evacuation or sheltering in place.

The next phase of KI distribution-- distribution to schools located within the 10-mile EPZs-- is about to begin. One tablet of KI will be made available for each student and staff person in time for the 2003/2004-fall term. The package of materials enclosed with this letter provides important information on KI: medical and historical information; the legal authority for teachers, nurses and other school personnel to distribute and administer KI; fact sheets for parents and teachers; a sample memorandum of understanding for incorporation of KI into local school health programs; a sample letter introducing this program to parents/guardians; and policy documents. The organizations that support use of KI and placing KI in schools, such as the Nuclear Regulatory Commission, the Food and Drug Administration, and the American Academy of Pediatrics are also listed, along with their recommendations, for your reference.

Please review the enclosed materials carefully. After evaluating the information on the program, please contact your local health director to address any questions or concerns and to schedule distribution of KI to your schools.
